All of vacated Blocks 4, 9 and 14 of TERMINAL CITY, a vacated subdivision of Klamath County, Oregon and those portion of vacated North Street, Cherry Street, Halo Street, Midway Avenue and the alleys within said Blocks.

ALSO...

Beginning at the point of the Intersection of the North line of Terminal City, a duly recorded, but vacated subdivision in Klamath County, Oregon, with the centerline of the Northerly terminus of Midway Avenue as said street is shown on the recorded plat of said Terminal City; thence, North 45 degrees 12' 48" East, 432.75, more or less, to 1/4 x 24" iron pin on the Southwesterly boundary line of the Southern Pacific Railroad right of way; thence, Southeasterly along said Railroad right of way line, 388.49 feet, more or less, to it's point of intersection with the North line of said Terminal City; thence, West along the North line of said Terminal City, 546.62 feet, more or less, to the point of beginning.
