Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

All that portion of Tract No. 25, Altamont Small Farms, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon more particularly described as follows:

Beginning at the Southeast corner of said Tract No. 25; thence North 0°11' East 213.87 feet; thence North 89°07' West 132 feet; thence South 0°11' West 214.67 feet, more or less, to the South boundary line of said Tract No. 25; thence 89°48' East along the South boundary line of said Tract 132 feet to the place of beginning.
