SUBORDINATION AGREEMENT

THIS SUBORDINATION AGREEMENT ("Agreement") is made and entered into this 5th day of November 2020, by and between **OREGON AFFORDABLE HOUSING ASSISTANCE CORPORATION** with an address of 725 Summer Street NE, Suite B, Salem OR 97301-1266, hereinafter called the "First Party" and Freedom Mortgage Corporation, with an address of 907 Pleasant Valley Ave, Suite 3, Mount Laurel, NJ 08054 hereinafter called the "Second Party".

WITNESSETH:

On or about July 5, 2018, Ronald L. Hugulet, being the owner (referred to hereinafter as the "Owner" or "Borrower") of property located in Klamath County, Oregon and described on Exhibit A hereto (the "Premises"), executed and delivered to the First Party a certain SUBORDINATE MORTGAGE (herein called the "First Party Lien") on the Premises, to secure the sum of \$60,000.00, which lien was recorded on July 24, 2018, in the Records of Klamath County, Oregon as Document No. 2018-008771.

The First Party is the legal and beneficial owner of the First Party Lien and the debt secured thereby which is evidenced by one or more promissory notes made by the Borrower in favor of the First Party.

Borrower wishes to obtain a loan from Second Party for the purposes of refinancing Borrower's current first mortgage loan on the Premises securing an estimated unpaid principal balance of \$190,535.23, in favor of Mortgage Electronic Registration Systems, Inc. Freedom Mortgage Corporation, recorded on February 18, 2020, in the Records of Klamath County, Oregon, as Document No. 2020-001999 which lien and the underlying debt shall be terminated upon such refinancing.

The First Party and the Second Party agree that the principal amount of such refinancing shall not exceed \$195,222.00, with interest thereon at a rate not exceeding 2.500% per annum, and a maturity date of 26 Years and 4 Months or 316 Months, and shall be secured by a certain

NOW, THEREFORE, for value received, and for the purpose of inducing the Second Party to make the loan aforesaid the First Party hereby agrees that the First Party's Lien is and shall be expressly subordinate and junior to the Second Party's Lien.

It is expressly understood and agreed that nothing herein contained shall be construed to change, alter or impair the First Party's Lien, except as herein above expressly set forth.

In construing this Agreement, and where the context so requires, the singular includes the plural, and all grammatical changes shall be made so that this agreement shall apply equally to corporations and to individuals.
