ALSO LESS AND EXCEPT any portion lying within State Highway 39 and State Highway 140, in the County of Klamath, State of Oregon.

Parcel 2:

Beginning at the Northwest corner of Tract 15 of JUNCTION ACRES; thence East along the North line of said Tract, 81 feet; thence South parallel with the West line of said Tract, 538 feet; thence West parallel with the North Line of said Tract, 81 feet to the West line; thence North 538 feet to a point of beginning, in the County of Klamath, State of Oregon.
