KNOW ALL MEN BY THESE PRESENTS, That

hereinafter called Grantee, and unto Grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in the County of **Klamath**, State of Oregon, described as follows, to wit:

A tract of land situated in the NW1/4 of Section 18, Township 39 South, Range 10 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Beginning at the Northwest corner of said Section 18; thence South 00°01'10" West along the West line of said Section 18, 2132.47 feet; thence South 89°51'42" East 2034.90 feet; thence North 00°00'23" East 404.05 feet; thence South 89°55'23" East 269.25 feet more or less to the true point of beginning; thence South 00°00'23" West 404.05 feet, more or less; thence South 89°55'23" East 269.25 feet, more or less; thence North 00°00'23" East parallel to the East line of the NW1/4 of Section 18, 404.63 feet, more or less; thence North 89°55'23" West 269.25 feet more or less, to the point of beginning.
