KNOW ALL MEN BY THESE PRESENTS, That Mike Sardina and Paula Sardina, hereinafter called the grantors, for the consideration hereinafter stated, to grantor paid by Mike Sardina and Paula Sardina, Trustees of the J and J LIVING TRUST hereinafter called the grantees, do hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Unit B, Building 1 Stage 10 Tract 1271 -Shield Crest Condominiums, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

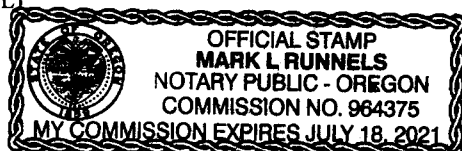
