The true and actual consideration for this conveyance is \$529,000.00.

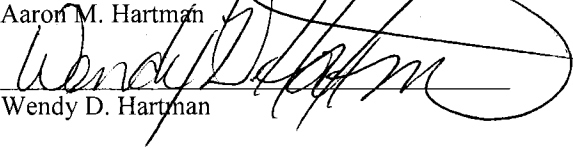

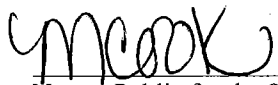
