Notice is hereby given that pursuant to ORS 93.740, the undersigned states:

1. On June 2, 2021, an Information was filed in the United States District Court for the District of Oregon.

2. In that Information, defendant Andrew Aaron Lloyd is charged with violations of Title 18, United States Code, Sections 1344, 1957, and 1028A. The Information also gives notice of criminal forfeiture pursuant to 18 U.S.C. § 982, against real property commonly known as **349 Martin Street, Klamath Falls, Oregon, 97601**, and more particularly described as:


All that portion of Lots 5 and 6, Block 21, Industrial Addition to the City of Klamath Falls, Oregon, in the County of Klamath, State of Oregon, more particularly described as follows: Beginning at the most Southerly corner of Lot 5 in said Block 21; thence Northwesterly along the Northeasterly line of Martin Street, a distance of 50 feet to the most Westerly corner of Lot 6 in said Block 21; thence Northeasterly along the line between Lots 6 and 7 in said Block a distance of 50 feet; thence Southeasterly parallel with Martin Street, a distance of 50 feet; thence Southwesterly along the line between Lots 5 and 6 in said Block a distance of 50 feet to the point of beginning.

3. The object of the forfeiture allegation in the Information is the forfeiture to the United States of America of the real property described above.

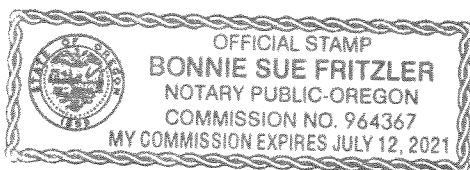
