The true and actual consideration for this conveyance is \$29,000.00.

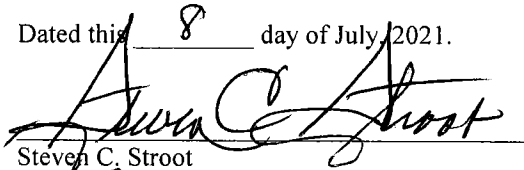

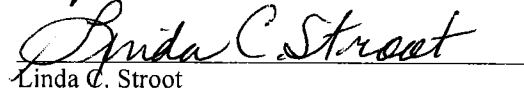
