Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, and 10 in Block 7 and Lots 1, 2, 3, 4 and 5 in Block 8 and that portion of Lots 8, 9, and 10 in Block 14 lying East of the highway, all in Opportunity Addition to the City of Klamath Falls;

ALSO all that portion of vacated "C" Street in Opportunity Addition to the City of Klamath Falls, Oregon, described as follows:

Beginning at the Southwest corner of Lot 6, Block 7 of said Opportunity Addition; thence, South to the intersection of the Northerly line of Oregon State Highway #97; thence, Northwesterly along said Northerly line of said Highway to its intersection with the South line of Lot 5 of said Block 7; thence, East to the point of beginning.
