Beginning on the West line of Lot A of Subdivision of Enterprise Tract No. 24, Klamath County, Oregon, 450 feet South of the Northwest corner of said Lot A, thence South along the West line of said Lot A 75 feet, thence East 299.5 feet, thence North 75 feet, thence West 299.5 feet to the place of beginning.
