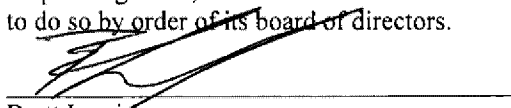
The true consideration for this conveyance is \$TO CONVEY TITLE.

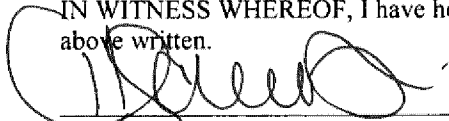

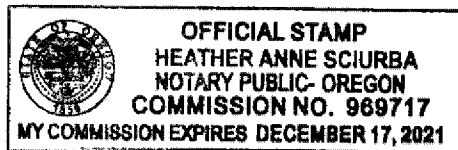

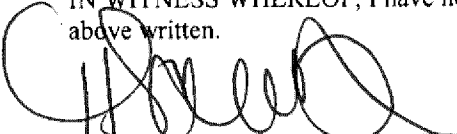
