Lot 53, Tract 1445, Regency Estates, Phase 3, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

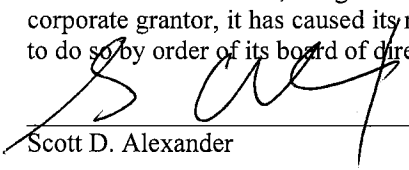
