THIS INDENTURE, Made this 10/28/2021, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Gorilla Capital OR PW, LLC an Oregon Limited Liability Company, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 19CV41686, Klamath County Sheriff's Office Number S21-0306, in which UNITED COMMUNITY BANK was plaintiff(s) and SWEET WOLVERINE MANAGEMENT LLC; SWEET WOLVERINE HOLDINGS LLC; PATRICK HANLEY; AND VERONICA (RONNIE) HANLEY was defendant(s), in which a Writ of Execution, which was issued on 03/03/2021, directing the sale of that real property, pursuant to which, on 04/28/2021 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$301,000.00, to Gorilla Capital OR PW, LLC an Oregon Limited Liability Company, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 

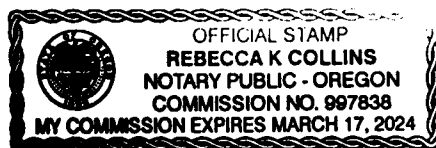


