THIS INDENTURE Made this 26th day of October, 2021, by and between

Dana Whitworth the duly appointed, qualified and acting personal representative of the estate of Eleanore I. Whitworth, deceased, Probate Case No.21PB01167, filed in Clackamas County, hereinafter called the first party, and
