PARCEL 1: (3909-00800-01300 and 02100)

Parcel 2 Land Partition 4-92 (Parcel 1 of Minor Land Partition 40-88) situated in the S1/2 of Section 8 and the NW1/4 of Section 17, Township 39 South, Range 9 East, Willamette Meridian, Klamath County, Oregon.

PARCEL 2: (3909-00800-00900)
