Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

## Parcel 1:

That portion of the W1/2 NW1/4 NW1/4 lying Southwesterly of the Keno Worden Road in Section 21, Township 40 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.

## Parcel 2:

That portion of the N1/2 SW1/4 NW1/4 and that portion of the W1/2 NW1/4 NW1/4 lying Southwesterly of the Keno Worden Road, all in Section 21, Township 40 South, Range 8 East of the Willamette Meridan, in the County of Klamath, State of Oregon. EXCEPTING THEREFROM that portion thereof described as follows:
