Parcel 2 of Land Partition 28-99, said land partition being a replat of Parcel 3 of Land Partition 5-97 and Lots 13-15 of Block 17 and the vacated alleys of Blocks 17 and 20 of WORDEN, situated in the SE1/4 of Section 33, Township 40 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon.
