Lot 26 of YALTA GARDENS, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

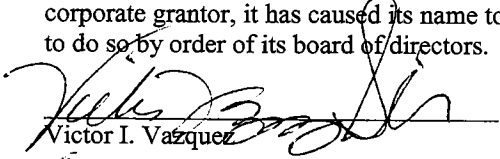

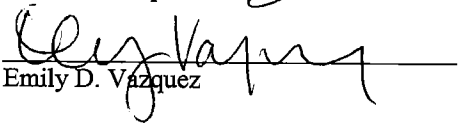
To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

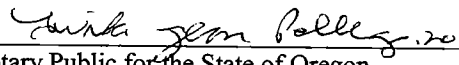
