The SE 1/4 of the SW 1/4 of Section 18, Township 37 South, Range 15 East of the Willamette Meridian, Klamath County, Oregon.

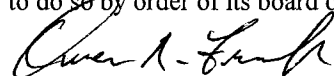
The true consideration for this conveyance is \$0.00.
