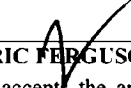
APPOINTMENT OF SUCCESSOR TRUSTEE AND DEED OF RECONVEYANCE

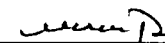

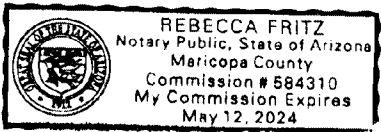

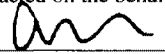
