AMENDMENT DECLARATION TO DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS AND EASEMENTS FOR RIDGEWATER

THIS AMENDMENT DECLARATION is made this <u>30th</u> Day of <u>September</u> <u>2021</u>, by TRINITY ASSET HOLDINGS CO., LLC a California limited liability company, successor declarant to Klamath Falls Partners, LLC, a Colorado limited liability company. ("Declarant"), RIDGEWATER COMMUNITY ASSOCIATION, an Oregon nonprofit corporation (the "Association"), and by the BOARD OF DIRECTORS ("Directors").

RECITALS

Pursuant to agreement of the Directors of the Association and Declarant the following revisions are approved to Amend the Master Declaration of the Association Declarations of Covenants, Conditions, Restrictions and Easements for RidgeWater. This revision is made to remove and correct the Buyer and Seller Fees payable to the Association at time of property title transfers.

REMOVAL of Article 4.3 Transfer Fee. This Article is removed in its entirety.

AMEND <u>Article 7.8 Prohibited Vehicles</u>. Amend the length of time for parking of recreational vehicles in driveways from 24 hours to 72 hours.
