Lot 6 of WINEMA GARDENS, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon. EXCEPTING THEREFROM the Northwesterly 17.9 feet thereof.

The true consideration for this conveyance is \$per dissolution.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
