### PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE Made this 5<sup>th</sup> day of March, 2022, by and between

James Birkendal Petersen the duly appointed, qualified and acting personal representative of the estate of Imperio Socorro Petersen-Scherer, deceased, Probate Case No. 21PB05903, filed in Klamath County,

hereinafter called the first party, and

**David McCammet and Evelyn McCammet, as Tenants by the Entirety,**

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

**Lot 16 LANDIS PARK, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.**

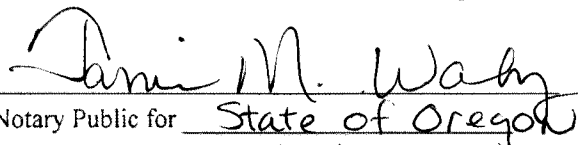
