A tract of land in the NE1/4 NE1/4 of Section 32, Township 38 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the Northwest corner of Block 78 of KLAMATH ADDITION to Klamath County, Oregon; thence North 38° 56' East, a distance of 204 feet to the point of beginning; thence South 51° 4' East, a distance of 100 feet; thence North 38° 56' East, a distance of 116 feet to a point; thence North 38° 51' West, a distance of 116 feet to the point of beginning.

NOTE: Said property is not platted however, it has been also described as Lots 1 and 2 and the Northeasterly 12 feet of Lot 3, all in Block 79, KLAMATH ADDITION, Klamath County, Oregon.
