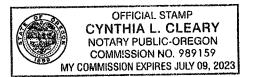

## EXHIBIT A (Legal Description)

A tract of land situated in NW1/4 of SE1/4 and the NE1/4 of SE1/4 of Section 18, Township 24 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at a point which is South 01°00'51" West 6.18 feet and East 38.14 feet from the 1/16<sup>th</sup> corner of the common line between the NE1/4 and the SE1/4 of said Section 18; thence South 1080.0 feet along the so called "false 1/16<sup>th</sup> line" which lies within the NE1/4 and is East of the common 1/16 line between the NW1/4 and NE1/4 of said SE1/4 of said Section 18 to the point of beginning; thence West 272.10 feet to a point; thence continuing West 64 feet, more or less, to the flow line of Crescent Creek; thence Northerly 120 feet, more or less, along the flow line of said creek to the intersection of the North line of said tract which is parallel to and 120 feet, more or less, North of the South line of said tract; thence East 45 feet, more or less, to a point; thence continuing East 285.40 feet to a point; thence South 120.0 feet along the "false 1/16<sup>th</sup> line" to the place of beginning.
