Change To: I, Daniel J. O'Connor, Surveyor, hereby certify that the interior monuments for the subdivision will be set on or before April 30, 2022, in accordance with ORS 92.060 and referenced on the plat for the subdivision as approved by Klamath County.

The following corrections on SHEET 3 - LEGEND of said plat is necessary and are as follows:

1. Change From: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap in City approved monument case to be set on or before December 31, 2019.

Change To: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap in City approved monument case to be set on or before April 30, 2022.

2. Change From: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap on 5 foot offset on lot line or radial to curve to be set on or before December 31, 2019.

Change To: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap on 5 foot offset on lot line or radial to curve to be set on or before April 30, 2022.

The following corrections on SHEET 4 - LEGEND of said plat is necessary and are as follows:

1. Change From: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap in City approved monument case to be set on or before December 31, 2019.

Change To: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap to be set on or before April 30, 2022.

2. Change From: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap on 5 foot offset on lot line or radial to curve to be set on or before December 31, 2019.

Change To: Set 5/8" x 30" Iron Pin with Tru-Line Surveying plastic cap on 5 foot offset on lot line or radial to curve to be set on or before April 30, 2022.

The following corrections on SHEET 3 of said plat is necessary and are as follows:

- 1. The monument case and monument at the intersection of Stiles Way and Mission Avenue is offset S00°38'15"E 5.00 feet.
- 2. The monuments at the intersection of Mission Avenue and Foster Avenue and the westerly terminus of Mission Avenue are 2" aluminum Bernsten caps marked "Tru-Line Surveying" and are epoxied in to the concrete.
- 3. The monument at the southerly terminus of Foster Avenue is a PK Nail. This point falls near the edge of the concrete. This monument will be reset with a 2" aluminum Berntsen cap marked "Tru-Line Surveying" when future street improvements are made on the next Plat Phase of Klamath Works Campus.

The following corrections on SHEET 4 of said plat is necessary and are as follows:

The 5 centerline monuments in unimproved Foster Avenue that are south of Stiles Way are 5/8" x 30" Iron Pins with Tru-Line Surveying plastic caps. Per the executed Agreement and Assurance of Performance Bond for this Plat; these monuments will be reset, following future street improvements, with 2" aluminum Bernsten caps marked "Tru-Line Surveying" to be epoxied in to the concrete.
