according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.**

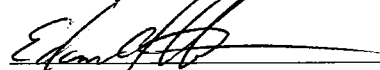
The true consideration for this conveyance is per Divorce Decree, Case #1404569CV.
