NW1/4 SW1/4 of Section 7, Township 40 South, Range 10 East of the Willamette Meridian, lying Northeasterly of the Klamath Falls-Malin Highway, Klamath County, Oregon, saving and excepting therefrom any portion lying within the right of way of the United States' C-7 lateral.

To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.
