## OREGON TRANSFER ON DEATH DEED (ORS 93.948-93.979)

Anita Brandl, aka Anita G. Brandl, GRANTOR, after her death conveys and transfer to Brenda L. Dole, BENEFICIARY, Grantor's right, title, and interest, including after acquired title, in that certain real property located in Klamath County, Oregon as more particularly on attached Exhibit A, which property was conveyed by Anita Wilson to Grantor by deed dated June 4, 1986 which was recorded in Deed Records of Klamath County State of Oregon on June 25, 1986 in Volume M86, pages 11071 and 11072.

Grantor, before her death retains the right to revoke this Deed in the manner allowed under Oregon's Uniform Real Property Transfer on Death Act, and during her lifetime retains all right, title and interest in the described real property. Grantor does not intend this deed to create in the Beneficiary a present interest, an equitable interest, or a legal interest in the real property described until the death of Grantor nor shall this deed affect any title, interest or right of Grantor as Owner under law or equity in the property described herein.
