RIGHT OF WAY EASEMENT

For value received, Richard Gerhart and Linda Gerhart, as tenants by the entirety ("Grantor"), hereby grant to PacifiCorp, an Oregon corporation, its successors and assigns, ("Grantee"), a perpetual easement for a right of way varying in width and containing 91,626 square feet, more or less, for the construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of Grantee's electric power transmission, distribution and communication lines and all necessary or desirable accessories and appurtenances thereto, including without limitation: supporting towers, poles, props, guys and anchors, including guys and anchors outside of the right of way; wires, fibers, cables and other conductors and conduits therefor; and pads, transformers, switches, vaults and cabinets, along the general course now located by Grantee on, over, across or under the surface of the real property of Grantor in Klamath County, State of Oregon, more particularly described as follows and/or shown on Exhibit(s) A & B attached hereto and by this reference made a part hereof:

A parcel of land situated in Sections 17 and 18, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Commencing at the intersection of the Northerly right-of-way line of Joe Wright Road, a county road, with the Easterly right-of-way line of the Dalles-California Highway U.S. No. 97 in the NE1/4 NE1/4 of Section 19, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon; thence North 03°38'00" East along the Easterly right-of-way line of said Dalles-California Highway 1220.68 feet to a 5/8 inch iron pin; thence continuing on said right-of-way line along the arc of a curve to the left, the chord of which being North 01°26'49" East 538.97 feet to a 5/8 inch iron pin; thence continuing on said right-of-way line along the arc of a curve to the left, the chord of which being North 04°10'15" West 108.07 feet to a 5/8 inch iron pin marking the True Point of Beginning for this description; thence along said highway right-of-way line and the arc of a spiral curve and simple curve to the left (delta = 13°40'; D = 2°; 400 foot spiral; $s = 4^{\circ}00^{\circ}$; a = 0.5; long chord = North 12°15'20" West 966.76 feet) to the end of curve; thence North 18°02'00" West 112.22 feet; thence leaving said highway right-of-way line and generally parallel to but approximately 100 feet Southerly of the low water line of the Klamath River the following courses and distances: North 32°12'35" East 124.47 feet; North 09°59'25" East 170.76 feet; North 21°09'12" East 379.56 feet; North 29°49'47" East 270.67 feet; North 52°06'05" East 166.04 feet; North 65°48'36" East 206.66 feet; South 88°18'30" East 203.96 feet; North 77°21'02" East 249.52 feet; North 71°32'21" East 386.45 feet; North 56°03'28" East151.34 feet to the Westerly right-of-way line of the Lost River Diversion Canal;

thence South 00°32'20" East 210.86 feet to a 5/8 inch iron pin; thence South 08°58'34" East 390.22 feet to a 5/8 inch iron pin; thence South 81°53'08" West 126.58 feet to a 5/8 inch iron pin; thence South 02°37'35" West 120.85 feet to a 5/8 inch iron pin; thence South 82°54'16" West 696.36 feet to a 5/8 inch iron pin on the Easterly right-of-way of the Dalles-California Highway which is the True Point of Beginning.

Together with the right of ingress and egress, for Grantee, its contractors, or agents, to the right of way from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the right of way and adjacent lands clear of all brush, trees, timber, structures, buildings and other hazards which might endanger Grantee's facilities or impede Grantee's activities.

At no time shall Grantor place, use or permit any equipment, material or vegetation of any kind that exceeds twelve (12) feet in height, light any fires, place or store any flammable materials, on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for other purposes not inconsistent, as defined by the Grantee, with the purposes for which this easement has been granted.

JURY WAIVER. TO THE FULLEST EXTENT PERMITTED BY LAW, EACH OF THE PARTIES HERETO WAIVES ANY RIGHT IT MAY HAVE TO A TRIAL BY JURY IN RESPECT OF LITIGATION DIRECTLY OR INDIRECTLY ARISING OUT OF, UNDER OR IN CONNECTION WITH THIS EASEMENT. EACH PARTY FURTHER WAIVES ANY RIGHT TO CONSOLIDATE, OR TO REQUEST THE CONSOLIDATION OF, ANY ACTION IN WHICH A JURY TRIAL HAS BEEN WAIVED WITH ANY OTHER ACTION IN WHICH A JURY TRIAL CANNOT BE OR HAS NOT BEEN WAIVED. THIS PARAGRAPH WILL SURVIVE THE EXPIRATION OR TERMINATION OF THIS AGREEMENT.

Grantor represents and warrants that it possesses all right, title and interest in and to the right of way area, free and clear of any lien, security interest, encumbrance, claim, license or other restriction that would interfere with Grantee's use of the right of way area for the purposes contemplated hereunder.

The rights and obligations of the parties hereto shall be binding upon and shall benefit their respective heirs, successors and assigns and shall run with the land.
