STATUTORY WARRANTY DEED

Grantor(s), hereby convey and warrant to

Alexis Bussey and Kevin Truett, not as tenants in common, but with rights of survivorship,

Grantee(s), the following described real property in the County of Klamath and State of Oregon free of encumbrances except as specifically set forth herein:

A portion of the N1/2 SW1/4 NW1/4 of Section 11, Township 39 South, Range 9, East of the Willamette Meridian, Klamath County Oregon, described as follows:

Beginning at a point marked by an iron pin driven in the ground in the center line of a 60 foot roadway, from which the section corner common to Sections 2, 3, 10 and 11, Township 39 South, Range 9 East of the Willamette Meridian, bears South 89° 44 1/2' West along the center line of said roadway, 744.4 feet to a point in the West boundary of said Section 11, and North 0° 13 1/2' West along the section line 1662.5 feet; running thence South 0° 07' East 331.95 feet to a point in the Southerly boundary of said N1/2 SW1/4 NW1/4 of Section 11; thence North 89° 42' East along said boundary line 67.5 feet; thence North 0° 07' West 331.90 feet more or less, to the center line of said roadway; thence South 89° 44 1/2' West along the center line of said roadway, 67.5 feet, more or less, to the point of the beginning.

The true and actual consideration for this conveyance is \$176,000.00.

The above-described property is free of encumbrances except all those items of record, if any, as of the date of this deed and those shown below, if any:


