The true and actual consideration for this conveyance is \$175,000.00.

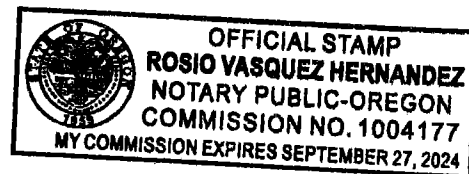
