The true and actual consideration for this conveyance is \$237,500.00.

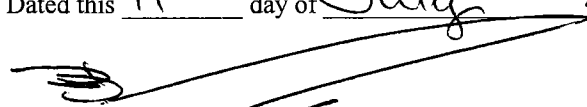
