according to the official plat thereof on file in the office of the County Clerk of Klamath County Oregon.**

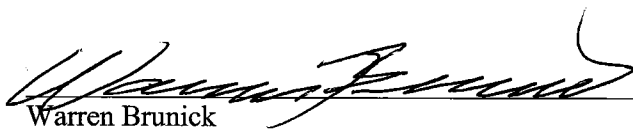
The true consideration for this conveyance is to clear title

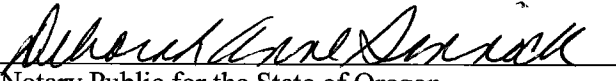
