KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto **Patrick S. Ramirez**, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

Description of real property: All of Lot 10, EXCEPT the North 400 feet and the East 1035 feet, Block 14, Klamath Forest Estates-Sycan Unit, in the County of Klamath, State of Oregon. * Falls

Subject to covenants, conditions, restrictions, easements, reservations, rights, rights of way and all matters appearing of record.


To Have and to Hold the same unto grantee and grantee's heirs, successors and assigns forever.

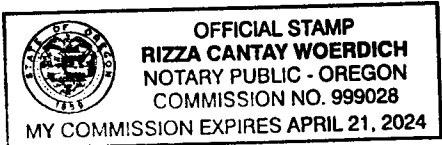


