THIS INDENTURE, made this 09/07/2022, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Gorilla Capital OR PW, LLC, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 20CV07815, Klamath County Sheriff's Office Number S21-0312, in which BANK OF NEW YORK MELLON TRUST COMPANY, N.A. 


