AMENDMENT TO BYLAWS OF LAKEWOODS OWNERS ASSOCIATION, INC. A NON-PROFIT CORPORTATION

The Bylaws of Lakewoods Owners Association, Inc. were recorded in the records of Klamath County, Oregon, on February 27, 2002 in Volume M02, Pages 12018-12034. The 2015 Amendment to Bylaws of Lakewoods Owners Association, Inc., a Non-profit Corporation, was recorded in the records of Klamath County, Oregon, on August 31, 2015, as Document No. 2015-009681 (collectively, "Bylaws").

This Amendment to Bylaws of Lakewoods Owners Association, Inc., a Non-profit Corporation ("Amendment") is made by the Lakewoods Owners Association, Inc., an Oregon nonprofit corporation (the "Association").

RECITALS

WHEREAS, Section 6 of Chapter 67, Oregon Laws 2021 (House Bill 2534), as amended by Chapter 367, Oregon Laws 2021 (House Bill 3041), requires an association of a planned community to review each governing document currently binding on the Association or the lots or lot owners within the Association and to amend or restate each document as necessary to remove all restrictions against the use of the Association or the lots not allowed under ORS 93.270 (2), or execute and record a declaration that the Association has reviewed the governing documents binding on the planned community and that the documents do not contain any restriction, rule or regulation against the use of the community or the lots by a person or group of persons because of race, color, religion, sex, sexual orientation, gender identity, national origin, marital status, familial status, source of income, disability or the number of individuals, including family members, persons of close affinity or unrelated persons, who are simultaneously occupying a dwelling lot within occupancy limits;

WHEREAS, in accordance with Section 6, Chapter 67, Oregon Laws 2021, as amended by Chapter 367, Oregon Laws 2021, the Board of Directors of the Association ("Board of Directors") have reviewed the governing documents currently binding on the Association or the lots or lot owners within the Association and determined that an amendment to the Bylaws is necessary to ensure compliance with House Bill 2534 and House Bill 3041;

WHEREAS, at the meeting of the Board of Directors held September 17, 2022, the Board of Directors voted to authorize and direct the President and the Secretary to execute this Amendment and cause it to be recorded in the Deed Records of Klamath County, Oregon, in accordance with Section 6, Chapter 67, Oregon Laws 2021.

AMENDMENT

NOW, THEREFORE, the Bylaws are hereby amended as follows:

1. The following Article X is hereby added to the Bylaws:

ARTICLE X GENDER; CAPTIONS

As used herein, the singular shall include the plural, and the plural the singular. The masculine, feminine and neuter shall each include all gender identities, as the context requires. All captions used herein are intended solely for convenience of reference and shall in no way limit any of the provisions of these Bylaws."

The undersigned President and Secretary of the Lakewoods Owners Association, Inc. hereby certify that the foregoing Amendment is made pursuant to Section 6 of Chapter 67, Oregon Laws 2021 (House Bill 2534), as amended by Chapter 367, Oregon Laws 2021 (House Bills 3041, collectively "House Bills"), and this Amendment does not change the Bylaws except as required under the House Bills and as may be necessary to correct scriveners' errors or to conform format and style. All other provisions of the Bylaws remain unmodified and in full force and effect.
