THIS INDENTURE, Made this 9/29/2022, by and between Chris Kaber, Sheriff of Klamath County, Oregon, hereinafter called the grantor, and Klamath County, A Political Subdivision of the State of Oregon, hereinafter called the grantee; WITNESSETH:

RECITALS: In a suit in the Circuit Court of the State of Oregon for Klamath County, Court Case Number 20-H-31, 20-H-227, 21-H-7, 21-H-34, 21-A-50, AND 21-A-71, Klamath County Sheriff's Office Number S22-0315, in which KLAMATH COUNTY, A POLITICAL SUBDIVISION OF THE STATE OF OREGON was plaintiff(s) and VICTOR TADD STONE was defendant(s), in which a Writ of Execution, which was issued on 01/05/2022, directing the sale of that real property, pursuant to which, on 03/30/2022 the real property was sold, subject to redemption, in the manner provided by law, for the sum of \$5345.00, to Klamath County, A Political Subdivision of the State of Oregon, who was the highest and best bidder, that sum being the highest and best sum bid therefore. 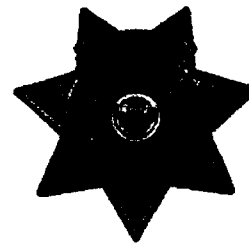

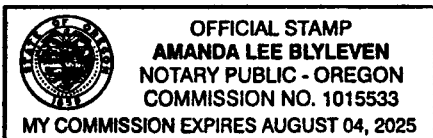
