MEMORANDUM OF LEASE AND TENANT'S RIGHT OF FIRST OFFER TO PURCHASE

THIS MEMORANDUM OF LEASE AND TENANT'S RIGHT OF FIRST OFFER TO PURCHASE (the "Memorandum") is made as of October 1, 2022, by and between RJG Corp., a Washington corporation, whose address is 3103 Washington St., Vancouver, WA 98660 ("Landlord") and G & G Electric and Plumbing Distributors, Inc., an Oregon corporation, whose address is 1900 NE 78th Street, Suite 101, Vancouver, WA 98665 ("Tenant").

WHEREAS, Landlord and Tenant are parties to that certain commercial lease dated March 5, 2004, and as amended and extended ("Existing Lease") for that certain real property identified on Exhibit A attached hereto (the "Premises");

WHEREAS, Landlord and Tenant entered into that new Commercial Lease dated October 1, 2022 for the Premises ("New Lease"); and

WHEREAS, by this Memorandum, the parties wish to provide notice of the termination of the Existing Lease and notice of the New Lease and certain provisions contained therein.

NOW, THEREFORE, the parties hereby give notice as follows:

- 1. <u>Termination of the Existing Lease</u>. Effective as of the Commencement Date (as defined below), the Existing Lease shall be terminated in its entirety and shall be of no further force or effect.
- 2. <u>Initial Term.</u> The term of the New Lease shall be for ten (10) years (the "<u>Initial Term</u>") and shall commence on October 1, 2022 (the "<u>Commencement Date</u>") and continue through September 30, 2032.
- 3. <u>Renewal Option</u>. If the New Lease is not in default at the time the option is exercised or at the time the renewal term is to commence, Tenant shall have the option to renew the New Lease for one (1) additional term of ten (10) years ("<u>Renewal Term</u>"), subject to the terms of the Lease. The Initial Term and Renewal Term shall collectively be referred to as the "Term".

- 4. <u>Tenant's Right of First Offer to Purchase</u>. Landlord granted Tenant a right of first offer to purchase the Premises, subject to the terms and conditions of the New Lease.
- 5. <u>Short Form Memorandum.</u> This Memorandum does not alter, amend, modify or change the New Lease in any way. All of the provisions of the New Lease are hereby incorporated by reference into this Memorandum. In the event of any conflict between the provisions of this Memorandum, the Existing Lease, and the New Lease, the provisions of the New Lease shall control.
- 6. <u>Counterparts</u>. This Memorandum may be executed in multiple counterparts and by the different parties hereto in separate counterparts, each of which shall for all purposes be deemed to be an original and all of which together shall constitute but one and the same instrument, with the same effect as if all parties to this Memorandum had signed the same signature part.
