**THIS INDENTURE Made this 27th day of September, 2022, by and between Sherry A. Decker the duly appointed, qualified and acting Personal Representative of the estate of Robert Wayne Skellham, deceased, Probate Case No. 21PB07845, filed in Lane County,**

**hereinafter called the first party, and**

**Randy G. Pultz and Shirley R. Tripp, Not as Tenants in Common but with right of survivorship,**

**hereinafter called the second party;**

**WITNESSETH:**

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

**Lots 7 and 8 in Block 6 of TRACT 1053 – OREGON SHORES, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.**
