plat thereof on file in the office of the County Clerk of Klamath County, Oregon.**

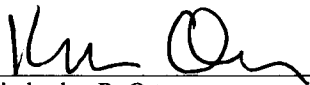
The true and actual consideration paid for this transfer, stated in terms of dollars, is **per Divorce Decree 21DR09287**.
