Lots 2,3 and N1/2 of Lot 4 in Block 5, The Terraces, according to the Plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars, is estate planning.

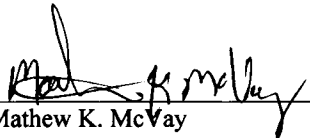
However, the actual consideration consists of or includes other property or value given or promised which is the whole / part of the consideration.
