PERSONAL REPRESENTATIVE'S DEED

THIS INDENTURE Made this 18 day of October, 2022, by and between Joshua McGinnis the duly appointed, qualified and acting personal representative of the estate of Deborah J. Clements, deceased, Probate Case No. 22PB00554, filed in Klamath County,

hereinafter called the first party, and

Ajenol D. Ortiz and Avelina E. Ortiz, as Tenants by the Entirety,

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Parcel 1 of Land Partition 12-94 situated in the SE 1/4 of the SW 1/4 of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.

The true and actual consideration paid for this transfer, stated in terms of dollars is \$220,000.00. However, the actual consideration consists of or includes other property or value given or promised which is part / whole of the consideration.
