THIS INDENTURE Made this 31 day of October 2022, by and between

Charles Jordan the duly appointed, qualified and acting personal representative of the estate of Mark J. Jordan,

hereinafter called the first party, and

hereinafter called the second party;

WITNESSETH:

For value received and the consideration hereinafter stated, the receipt whereof hereby is acknowledged, the first party has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the said second party and second party's heirs, successors-in-interest and assigns all the estate, right and interest of the said deceased at the time of the decedent's death, and all the right, title and interest that the said estate of said deceased by operation of the law or otherwise may have thereafter acquired in that certain real property situated in the County of Klamath, State of Oregon, described as follows, to-wit:

That portion of the SE1/4 SW1/4 NE1/4 and the S1/2 SW1/4 SW1/4 NE1/4 of Section 16, Township 31 South, Range 7 East of the Willamette Meridian, lying East of the Oregon State Highway No. 232, Klamath County, Oregon.

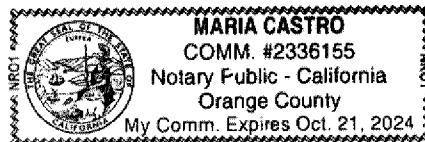

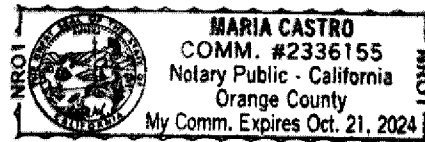
