FIRST AMENDMENT TO MEMORANDUM OF HYDROELECTRIC FACILITIES AND ROAD ACCESS EASEMENT AGREEMENT

THIS FIRST AMENDMENT TO MEMORANDUM OF HYDROELECTRIC FACILITIES AND ROAD ACCESS EASEMENT AGREEMENT (this "Amended Memorandum") is made and entered into as November 3, 2022 (the "Effective Date") by and among Green Diamond Resource Company, a Washington Corporation ("Grantor") and Swan Lake North Hydro, LLC, a Delaware limited liability company (the "Grantee").

A. Grantor and Grantee entered into that certain Hydroelectric Facilities and Road Access Easement Agreement, dated and effective August 11, 2022, as amended (the "Easement"), as evidenced by that certain Memorandum of Hydroelectric Facilities and Road Access Easement Agreement, dated and effective August 11, 2022 recorded among the land records of Klamath County, Oregon on August 17, 2022 as instrument number 2022-010026 (the "Memorandum of Easement") whereby Grantor granted an easement to Grantee over certain real property located in Klamath County, Oregon, as more particularly described in the Memorandum of Easement (the "Property").

WHEREAS, Grantor and Grantee desire to amend the Memorandum of Easement as provided herein.

- 1. All defined terms used herein shall have the meaning as set forth in the Memorandum of Easement or Easement, as applicable.
- 2. Section (C)(a) of the Memorandum of Easement is hereby deleted and replaced with the following:
 - a) Among other terms and conditions, the Agreement provides that, unless terminated sooner in accordance with the Agreement, the Easements granted to Grantee pursuant to the Agreement shall each commence on the Effective Date and shall continue in effect until the earlier to occur of the following: (i) the date of expiration of the current term of the license granted by the Federal Energy Regulatory Commission ("FERC") for operation of the Project (the "Project Permit"), as it may be extended, or (ii) if after commencing operations of the

Project, Grantee ceases to operate the Project and does not resume operations within a continuous eighteen (18) month period (for reasons other than Force Majeure or the overhaul of the Project). Among other grounds for termination, the Easements may also be terminated by the Grantee upon thirty (30) days' written notice and further may be terminated automatically upon any of the following: (i) mutual agreement of the parties to terminate the Agreement; (ii) if FERC does not, by June 30, 2020 approve the Project or issue a Project permit allowing Grantee to construct and operate the Hydroelectric Energy System on the Property, or following any such approval or certificate issuance by FERC, Grantee thereafter fails to: (A) accept such Project permit, (B) obtain all other necessary permits for construction and operation or (C) receive a final FERC authorization order and notice to proceed with construction of the Project; (iii) If after commencing operations of the Project, Grantee ceases to operate the Project and does not resume operations of the project within a continuous eighteen (18) month period (for reasons other than Force Majeure or the overhaul of the Project); (iv) upon any material breach or nonperformance of any of Grantee's obligations under the Agreement (including breach by any agent, contractor or licensee exercising any rights of Grantee); provided, that Grantor has first provided Grantee not less than thirty (30) days prior written notice specifying the nature of the breach or nonperformance with reasonable particularity and Grantee is given an opportunity to cure the breach or nonperformance (or to commence and diligently pursue curative measures) within such thirty (30) day period; or (v) Grantee: (A) becomes insolvent, (B) is generally unable to pay, or fails to pay, its debts as they become due, (C) files, or has filed against it, a petition for voluntary or involuntary bankruptcy or pursuant to any other insolvency laws, (D) makes or seeks to make a general assignment for the benefit of its creditors, or (E) applies for, or consents to, the appointment of a trustee, receiver or custodian for a substantial part of its property or business.

- B. This Amended Memorandum is executed and recorded solely for the purpose of providing record notice to third parties of the amended terms of the Easement and Amended Memorandum. In the event of any conflict between any term or provision of the Easement and this Amended Memorandum, the applicable term or provision of the Easement shall control. Reference is made to the Easement for all remaining terms, covenants, and conditions thereof.
- C. This Amended Memorandum may be executed in separate counterparts, each of which shall be deemed an original but all of which together shall constitute one and the same Amended Memorandum.
