# CERTIFICATE OF TRUST (ORS 130.860)

#### 1. <u>Date of Existence and Execution of Trust.</u>

The trust was executed on August 18, 1994, and is currently in existence.

#### 2. Trustor/Trustee.

- a. The Trustor is: SYDNEY KERNS GIACOMINI
- b. The currently acting Trustee is: ELENA G. COOPER

#### 3. Trust Powers.

The powers of the Trustee are as follows:

The Trustee is empowered to do all things appropriate for the orderly administration of the trust subject to the Trustee's power and control, unless otherwise specifically provided herein. Without limiting this general power, and without limitation of other powers hereby granted or otherwise possessed by the Trustee, including those specified in the Uniform Trustees' Powers Act in effect in Oregon as it may be amended from time to time, the Trustee shall have the following powers and discretion, which the Trustee shall exercise in such manner and upon such terms and conditions as the Trustee shall deem necessary, desirable or convenient:

- (a) MANAGE AND DISPOSE OF ASSETS. Manage, maintain, improve, lease, grant options on, encumber, sell, exchange, or otherwise dispose of part or all of the trust estate in any manner and on any terms my trustee considers beneficial to the trust estate.
- (b) RETAIN ASSETS. Retain any property and continue to operate any business for so long as my trustee considers retention of probable benefit to the trust estate and the trust beneficiaries.
- (c) MAKE INVESTMENTS. Invest and reinvest the trust estate in common or preferred stocks, bonds, mutual funds, common trust funds, secured and unsecured obligations, mortgages, and other property, real or personal, which my trustee considers advisable and in the best interest of the trust estate, whether or not authorized by law for the investment of trust funds.
- (d) RECEIVE COMPENSATION. Receive reasonable compensation for my trustee's own services and reimbursement for expenses incurred in administering the trust estate.
- (e) ADVANCE FUNDS OR BORROW. Advance my trustee's own funds to the t rust for any trust purpose at prevailing rates of interest (with any advance to be a lien on the trust estate) and borrow money for those purposes and upon those terms and conditions which my trustee considers to be in the best interest of the trust estate.

- (f) PURCHASE ASSETS AND MAKE LOANS. Purchase assets at their fair market value (as determined by my trustee) from my probate estate, and make secured or unsecured loans to my probate estate, for any reason my trustee believes will benefit my probate estate.
- (g) COMBINE MANAGEMENNT OF SEPARATE TRUSTS. Hold the trust estate as an undivided whole without separation into any separate trusts for as long as my trustee considers suitable and allot undivided interests in any asset to any separate trusts, but no undivided holding shall defer vesting or distribution under the trusts.
- (h) CHOOSE MANNER OF MAKING DISTRIBUTIONS. Make any distribution in any of the following ways to a beneficiary who is a minor, incapacitated, under legal disability, or considered by my trustee to be unable to handle property if paid to the beneficiary directly, without liability to my trustee:
  - (1) Direct to the beneficiary.
- (2) To the extent permitted by Oregon law, to a custodian for that person under the Oregon Uniform Transfers to Minors Act until the person attains the age of 25 years.
- (3) To the beneficiary's guardian, conservator, or any other fiduciary for the beneficiary.
- (4) To any person or organization furnishing health care, education, support, or maintenance.
- (5) To the trustee of a receptacle trust for the lifetime of a beneficiary with a disabling condition and receiving, or likely to receive, public benefits, so long as such trust is a supplemental needs trust, to protect the eligibility of the beneficiary for needs-based public benefits. The remainder beneficiaries of the receptacle trust must be the remainder beneficiaries set out in this instrument for that beneficiary's distribution, had the beneficiary died. I anticipate that the receptacle third party special needs trust will be created at that time by an interested person, and funded with the distribution.
- (i) DEAL WITH ENVIRONMENTAL MATTERS. Inspect and monitor property to determine compliance with environmental laws, take action to prevent or remedy violations, settle environmental claims, decline to accept property which could result in liability under environmental laws or impair the value of the trust estate, and disclaim any power which could cause my trustee to incur personal liability for violation of environmental laws. My trustee shall not be liable to any trust beneficiary for any decrease in the value of the trust estate as a result of these actions.
- (j) UNPRODUCTIVE PROPERTY. My partner, if an income beneficiary of a trust under this instrument, may require that the Trustee not retain in the trust beyond a reasonable time any property that may be or become unproductive and may require that the Trustee not invest the property of such trust fund in unproductive property.
- (k) DO OTHER ACTS. Except as otherwise provided in this instrument, do all acts that might legally be done by an individual in absolute ownership and control of property and which in my trustee's judgment are necessary or desirable for the proper and advantageous management of the trust estate.


