## DECLARATION OF NONDISCRIMINATION FOR RUNNING Y RANCH RESORT OWNERS ASSOCIATION (SECTION 4, CHAPTER 67, OREGON LAWS 2021; ORS 93.270)

THIS DECLARATION OF NONDISCRIMINATION FOR RUNNING Y RANCH RESORT (SECTION 4, CHAPTER 67, OREGON LAWS 2021; ORS 93.270) (this "Declaration") is dated as of December 23, 2022, and is made by RUNNING Y RANCH RESORT OWNERS ASSOCIATION, an Oregon nonprofit corporation ("Association").

## **RECITALS**

- A. The Association is the homeowners association for the planned community in Klamath County, Oregon, known as Running Y Ranch Resort, pursuant to that certain Amended and Restated Declaration of Protective Covenants, Conditions, Restrictions and Easements for Running Y Ranch Resort recorded in the Klamath County Official Records as Instrument No. 2018-007433 (as amended and supplemented from time to time, the "CC&Rs").
- B. The Association records this Declaration in conformance with Section 4, Chapter 67, Oregon Laws 2021.

NOW, THEREFORE, the Association declares as follows:

- 1. <u>Compliance</u>. In compliance with Section 4, Chapter 67, Oregon Laws 2021, the Association has reviewed the Association's governing documents (as defined in ORS 94.550(13)) and determined that they do not contain any restriction, rule or regulation against the use of the community or the lots and units within the community by a person or group of persons because of race, color, religion, sex, sexual orientation, gender identity, national origin, marital status, familial status, source of income, disability or the number of individuals, including family members, persons of close affinity or unrelated persons, who are simultaneously occupying a dwelling unit within occupancy limits.
- 2. <u>Defined Terms</u>. Capitalized terms used herein without definition shall have the meaning given them in the CC&Rs.
