KNOW ALL BY THESE PRESENTS this deed, made this 9th day of January, 2023, between Rick Vaughn, TAX COLLECTOR, Klamath County, State of Oregon, "Grantor", and KLAMATH COUNTY, a Political Subdivision of the State of Oregon, "Grantee",

RECITALS

Pursuant to ORS 312.100 the said properties on the list attached hereto as "Exhibit B" were ordered sold to Klamath County, Oregon, subject to the right of redemption as provided by law. A General Judgment was entered in the Circuit Court of the State of Oregon for the County of Klamath on September 29, 2022 Case No. 22CV28356 in favor of Klamath County, Oregon, and against Adams John E Jr, Agliolo Neil Robert, et al.


In accordance with ORS 312.122, a county may by ordinance provide the means to require the tax collector of the county to deed to the county pursuant to ORS 312.200 any real property sold to the county under ORS 312.100 after the expiration of the 30-day period if the property is subject to waste and/or abandonment. Order 2023-041 attached hereto as "Exhibit A", issued by the Klamath County Board of County Commissioners on December 6th, 2022, states that the Klamath County Tax Collector shall deed the properties in "Exhibit B" to Klamath County at the end of the thirty-day expiration period if not sooner redeemed by the former property owners.

A notice of hearing was mailed via certified mail to the former property owners and lien holders on October 27, 2022. A public hearing notice was advertised in the Herald and News on Saturday, November 12th, 2022 and Friday, November 25th, 2022. The advertisement is attached hereto as "Exhibit C".

The properties were not redeemed as provided by law.


NOW, THEREFORE, KLAMATH COUNTY TAX COLLECTOR RICK VAUGHN, Grantor, by virtue of the statutes of the State of Oregon, do hereby sell and convey unto Klamath County, Oregon, as Grantee, and its assigns forever, the properties described in the attached "Exhibit B"



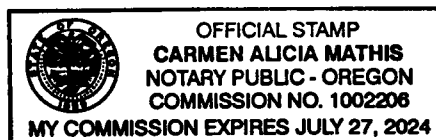
