PARTIAL RELEASE OF SUBORDINATION AGREEMENT

FOR VALUABLE CONSIDERATION, the receipt and sufficiency of which is hereby acknowledged, ALLY BANK (Ally Capital in Hawaii, Mississippi, Montana and New Jersey), a Utah state-chartered bank ("Bank") hereby remises, releases, conveys, and quit claims any right, title, interest, claim or demand that Bank may have acquired in the parcels of land described in Exhibit A attached hereto (the "Released Parcel") created by the following (the "Security Instrument"):

That certain Subordination and Attornment Agreement (the "<u>Agreement</u>") made by and between KLAMATH FALLS PROPERTY HOLDINGS LLC, an Oregon limited liability company ("<u>Landlord</u>"), TAG KFS, INC. DBA KLAMATH FALLS SUBARU, an Oregon corporation ("<u>Tenant</u>") and Bank, dated June 30, 2021 and recorded on July 2, 2021 with the Klamath County, Oregon Recorder as Document No. 2021-010406.

This partial release is not a general release and does not constitute a release and satisfaction of the indebtedness secured by the Security Instrument. This partial release only releases the lien of the Security Instrument from the Released Parcels and does not release: i) the lien of the Security Instrument from any other property encumbered by the Security Instrument; or ii) Borrowers from any liability or obligation under any Commercial Real Estate Loan and Security Agreement and Promissory Note from Landlord to Bank secured by the Security Instrument (as amended, the "Loan Agreement"). Except as specifically set forth herein, the Security Instrument and the Loan Agreement remain unchanged and in full force and effect.
